The purpose was to provide housing and support services to strengthen sustained recovery and self-sufficiency of homeless families in treatment and recovery from substance abuse. Dayspring's Head Start services target low-income families with a special emphasis on substance abuse prevention programs.

Dayspring provides a Head Start program serving 584 children. Head Start centers provide developmentally appropriate activities for children and parenting education activities for parents. Substance
