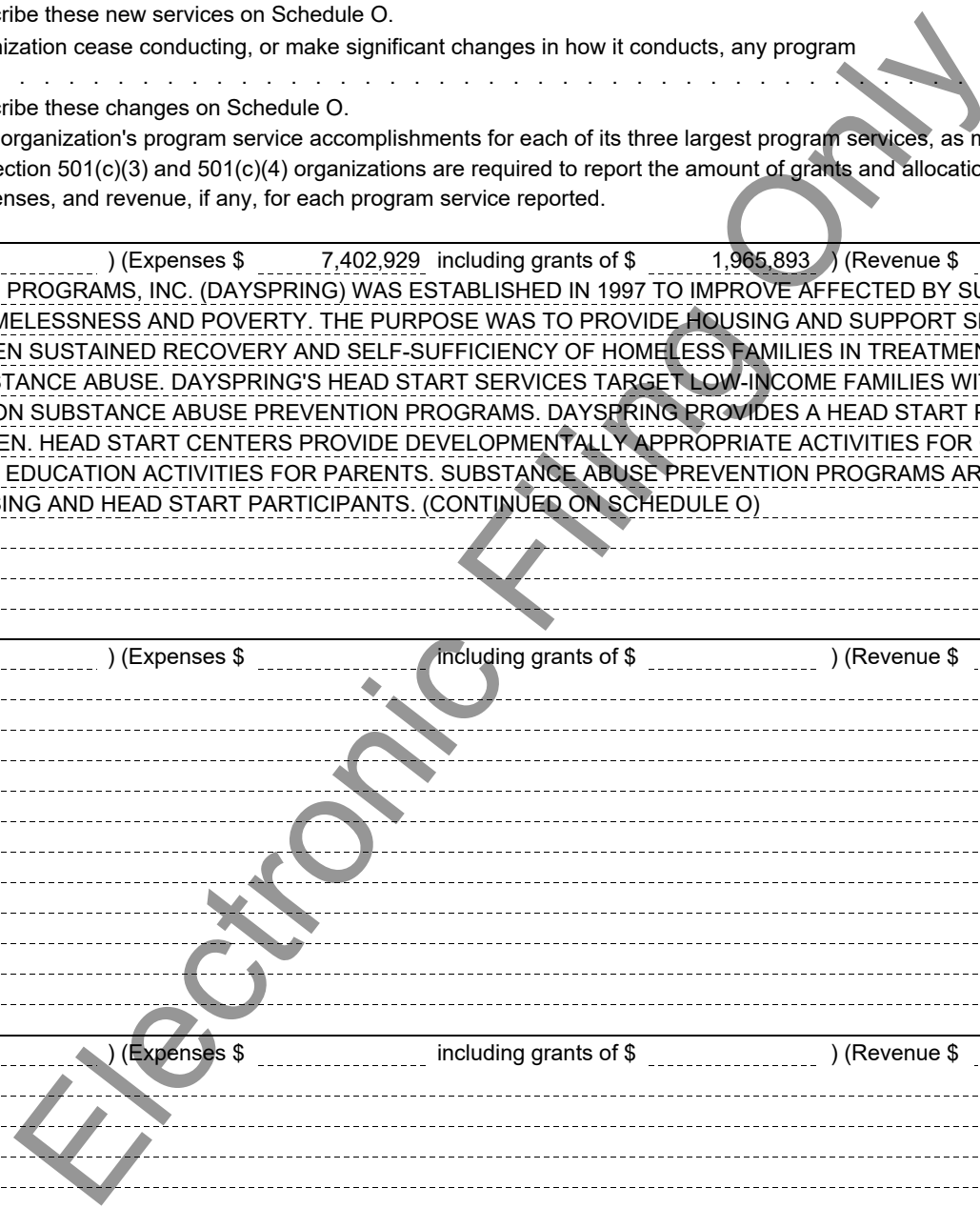

THE PURPOSE WAS TO PROVIDE HOUSING AND SUPPORT SERVICES TO STRENGTHEN SUSTAINED RECOVERY AND SELF-SUFFICIENCY OF HOMELESS FAMILIES IN TREATMENT AND RECOVERY FROM SUBSTANCE ABUSE. DAYSPRING'S HEAD START SERVICES TARGET LOW-INCOME FAMILIES WITH A SPECIAL EMPHASIS ON SUBSTANCE ABUSE PREVENTION PROGRAMS. DAYSPRING PROVIDES A HEAD START PROGRAM SERVING 499 CHILDREN. HEAD START CENTERS PROVIDE DEVELOPMENTALLY APPROPRIATE ACTIVITIES FOR CHILDREN AND PARENTING EDUCATION ACTIVITIES FOR PARENTS.
