(Dayspring) was established in 1997 to improve the quality of life for children and families focusing on those affected by substance abuse, homelessness and poverty. The purpose was to provide housing and support services to strengthen sustained recovery and self-sufficiency of homeless families in treatment and recovery from substance abuse. Dayspring's Head Start services target low-income families with a special emphasis on substance abuse prevention programs.

Dayspring provides a Head Start program serving 584 children. Head Start centers provide developmentally appropriate activities for children and parenting education activities for parents. Substance
